2.0 Committee Member Reapplication Motion

As committees complete the recharter process, there may be changes to committee purposes, tasks and deliverables which may change the desirable knowledge, skills and abilities for committee member.

As well, committee applications may change over time. Requiring sitting committee members to submit a new application allows for an equitable review for appointment of potential members by the chair/chair-designate.

Reapplication for a second term is a requirement for the Board of Directors.

MOTION: Paul Zinni moved the motion to require committee members to reapply for a second consecutive term on a committee.

Further moved, to update CEC's Policy Manual Section 2, Part 2 (Committees), Paragraph 3 (Appointment to Committees), subparagraph g. as follow:

Committee members may be appointed <u>reapply to be considered</u> for a consecutive term. A third consecutive term is not permitted. However, a person who has served two consecutive terms will become eligible <u>may reapply</u> for another term following a one-year break in service.

Mitch Yell seconded.

Motion passed.

3.0 Division Service Fees Modification Motion

Currently, CEC withholds service fees based on a percentage of salaries and benefits for two employees of its membership department. As Division memberships have declined over several years, the service fees have remained relatively stable, causing an average percentage withheld from Divisions in 2019 of 18.3%. By charging a flat amount of 12.5%, the Divisions will pay less in times of dues decline, as is currently the case. The flat service fee is also more transparent and will benefit the Divisions and CEC in times of membership increase. A service fee of 12.5% is also equivalent to the service fees withheld from Unit dues.

MOTION: Rafael CdeBaca moved the motion to revise the way CEC withholds division service fees and add the following service fee structure to the Policy Manual Section 2, Part 3 (Units), Chapter 5 (Divisions), Paragraph 3 (Requirements of a Division):

CEC will withhold a service fee of 12.5% of the total dues collected for each Division on a quarterly basis. The service fee is withheld to partially offset CEC overhead costs in support of each Division.

Further moved, that this will be implemented beginning Jan. 1, 2020.

Linda Balon-Smith seconded.

Motion passed.
