What's Covered

With the Student Educator Professional Liability Plan, you will be protected against a broad range of exposures associated with your student teaching duties, including the following allegations:

After a \$100 deductible, the plan also pays 90 percent of your attorney's fees if you:

- ◆ Are accused of sexual misconduct, provided you are found not guilty or the charges are dismissed (\$35,000 maximum per policy period).
- ◆ Face criminal charges arising out of corporal punishment, provided you are found not guilty or the charges are dismissed (\$10,000 maximum per policy period).
- ◆ Are named in a lawsuit seeking non-monetary relief (\$35,000 maximum per policy period).

Eligibility

As a Pre-Service Student Member of CEC, you are automatically insured for \$1,000,000 of professional liability coverage. You must be a student member in good standing of CEC preparing for employment performing educational duties under the supervision of a licensed educator.

Your plan will provide coverage for claims brought at any time, as long as the occurrence that resulted in litigation occurred while your Student Educator Professional Liability policy was in effect. The policy term is for one year and renewable each year as part of your CEC membership.

Limitations

This plan is available to CEC student members residing in the United States and the District of Columbia.

Filing a Claim
