As the recognized leader for special education professional standards, the Council for Exceptional Children (CEC) develops standards, ethics, practices, and guidelines to ensure that special educators are better prepared for successful, long-term careers.

The Professional Preparation Standards define the specialized expertise special educators must master for safe and effective practice and are used to inform preparation programs, accreditation processes, and credentialing agencies. CEC has, and continues to use, a collaborative process that ensures its standards are current, research-based, and designed to fully address the knowledge and skills special educators must master. CEC has developed and maintains six sets of professional standards.

Terminology

It is important to ensure that audiences have a common understanding when referring to work related to CEC's standards, national recognition, and accreditation processes, as various organizations may use terms differently and/or interchangeably. The following terms and accompanying definitions below are guidelines for use within CEC processes to ensure common understanding and coherence amongst documents and processes.

Standards: The Professional Standards define the specialized expertise special educators must master for safe and effective practice. These standards are used to inform special educator preparation programs, accreditation organizations, and credentialing agencies. CEC has six sets of professional standards.

Initial-Level Program: Initial-level programs prepare candidates for their first special educator license and/or credential. An initial-level program may be at the undergraduate or graduate level.

Advanced-Level Program: Advanced-level programs are designed to support current special educators who seek to deepen their skills and broaden their knowledge base by seeking an additional license and/or credential. Though most advanced level programs will be at the graduate level, the terms are not interchangeable.

Specialty Sets: The specialty sets delineate the essential knowledge and skills that beginning special education professionals must possess to be ready to begin their practice in specific areas. Specialty sets are designed to be used in conjunction with a corresponding set of CEC standards.

National Recognition: The process for the programmatic review of specialty licensure areas conducted in partnership with the Council for the Accreditation of Educator Preparation (CAEP) for Educator Preparation Providers (EPPs) seeking CAEP Accreditation. Programs that demonstrate meeting the CEC Standards during their review will be awarded the status of National Recognition.

Accreditation: CEC Accreditation refers to the process of which educator preparation programs seek a formal evaluation of meeting CEC Standards. CEC Accreditation applies to the program only and does not credential an individual person or group of people.
