Jared is a thoughtful, respectful, and active participant in his IEP meetings and communicates openly with teachers, helping foster an inclusive and supportive learning environment. "Jared's growth in self-awareness and communication has empowered him to take charge of his learning," shares his nominator. "He has become more independent, confident, and resilient. His sincerity, honesty, and unique perspective make him an outstanding and inspiring individual."
